LEADERSHIP EDUCATIONAL SESSION Comm. McLaughlin called the July 1, 2022 Education Meeting of the Board of Commissioners of King County Public Hospital District

Comm. McLaughlin welcomed everyone to the meeting and noted that recent OPMA changes require public comment be taken for all forms of action including unofficial endorsement or general guidance. Research Discussion

Peggy Brown, Chief Marketing and Communications Officer Consultant, and Karen Waters and Ben Anderstone of Strategies360, continued the research discussion from the June 21, 2022 Board meeting. The team reviewed the process for the research and the results of the analysis as well as recommendations. The Board shared their thoughts on the topic and engaged in discussion throughout.

Additionally, Dr. Tomlin gave a brief CEO update which included updates regarding local bed shortage issues, the Supreme Court ruling on Roe v. Wade and its impact on EvergreenHealth, etc. and responded to questions from the Board.
